

**Amendment to Direction No.38 of 2016 (M.Ed.)**

**Direction No.7 of 2017**

**Examinations leading to the Degree of Master of Education, first to last semester in Choice Based Credit System, Semester pattern in the faculty of Education (amendment, Direction, 2017). Issued under provision of section of sub section (8) of section 12 of the Maharashtra Public Universities Act, 2016**

Whereas, Direction No. 38 of 2016 in respect of Direction regarding Choice Based Credit System semester pattern scheme and examination leading to M. Ed. first to last semester in Choice Based System Semester pattern in the Faculty of Education, Rasthrasant Tukadoji Maharaj Nagpur University, Nagpur is in existence in the university which was issued by the then acting Vice-Chancellor on 15-6-2016;

AND

Whereas, provision for allowing to keep term in the next higher class is made in the above said direction under clause iii of para 17 of the said direction No. 38 of 2016.

AND

Whereas, original ordinance No. 10 in respect of providing for exemption and compartment is in existence in the university and provision under 5<sup>th</sup> proviso of sub para (1) of para 2 is made for allowing to keep term in the next higher class of M.Ed course is made in the said ordinance which is as follows:

“Provided further that for the Master’s Degree Part I Summer examination of 1994, ATKT concession shall be granted to the failures of Master’s Degree part I Examination of the University in the faculty of Arts, Science, Social Science, Commerce, Home Science, MPEd Part I in the faculty of Education and Part II of M.Sc. “Tech.”). (Applied Geology) examination of the university, in the Faculty of Science, on getting exemption in 2/3 the Number of paper passing head prescribe for the examination. **(As per the scheduled appended to this ordinance)** Calculation of 2/3 the number of passing paper/heads of passing shall be as per table given in the

explanation–1 of the said ordinance No.10 in respect of providing for exemption and compartment.

AND

Whereas, the provision made under clause III of para 17 of Direction No.38 of 2016 is inconsistent with the provision made under 5<sup>th</sup> proviso of sub para (1) of para 2 of Ordinance No.10 in respect of providing for exemption and compartments’;

AND

Whereas, the inconsistency appear in Direction No. 38 of 2016 regarding the matter of ATKT is to be removed for the benefit of the students admitted for the Degree of Master of Education in the Faculty of Education;

AND

Whereas, the matter is required to be regulated by an Ordinance and Direction No.38 of 2016 is not converted in to an Ordinance.

AND

Whereas, the matter provided under clause iii of Para 17 of Direction No.38 of 2016 is required to be withdrawn from the said Direction.

AND

Whereas, the matter is to be regulated immediately for the benefit of the students for their admission on the basis of ATKT rules applicable to the Degree of Master of Education in the Faculty of Education.

Now, therefore, I, Dr. Siddarthavinayak P. Kane, Vice-Chancellor, Rashtrasant Tukadoji Maharaj Nagpur University, in exercise of the powers conferred upon me under sub section (8) of section 12 of the Maharashtra Public Universities Act 2016 i.e. Maharashtra Act No.vii of 2017, do hereby issue following directions:

1. This Directions shall be called “Examinations leading to the degree of Master of Education, first to last semester in Choice Based Credit System, semester pattern in the faculty of Education (amendment Direction, 2017).”
2. This direction shall come into force with effect from the date of its issuance;
3. Provision made under clause iii of Para 17 of Direction No.38/2016 relating to Master of Education, first to last semester in Choice Based Credit System Semester pattern for the award of Degree of Master of Education (2 year Degree Course), full time in the faculty of Education, is hereby withdrawn.
4. Provision made under proviso 5<sup>th</sup> of sub para into (1) of para 2 of original Ordinance No.10 in respect of providing for exemption and compartment shall be applicable to the students of the Master of Education Degree Course from the session 2016-2017.
5. Provision made under 5<sup>th</sup> proviso of sub para (1) of para 2 of original Ordinance No.10 in respect of providing for exemption and compartment is based on the annual pattern system of the examination for the purposes of allowing to keep term in the next higher class. This annual pattern system of examination be treated as semester pattern system of for the purposes of ATKT of M.Ed course (Two Years) examinations.
