

Amendment to Direction No.19 of 2015 (B.P.Ed)

Direction No.8 /2017

Examinations leading to the Degree of Bachelor of Physical Education (B.P.Ed), first to last semester in Credit Based Semester pattern in the faculty of Education (amendment, Direction, 2017). Issued under provision of section of sub section (8) of section 12 of the Maharashtra Public Universities Act, 2016

Whereas, Direction No. 19 of 2015 in respect of Direction regarding Credit Based semester pattern scheme and examination leading to B.P.Ed first to last semester in Credit Based System Semester pattern in the Faculty of Education, Rasthtrasant Tukadoji Maharaj Nagpur University, Nagpur is in existence in the university which was issued by the then Vice-Chancellor on 8-9-2015;

AND

Whereas, provision for allowing to keep term in the next higher class is made in the above said direction under clause 2 of para 15 of the said direction No. 19 of 2015.

AND

Whereas, original ordinance No. 10 in respect of providing for exemption and compartment is in existence in the university and provision under 5th proviso of sub para (1) of para 2 is made for allowing to keep term in the next higher class of B.P.Ed course is made in the said ordinance which is as follows:

“Provided further that for the Summer Examinations of 1984 A.T.K.T Concession shall be granted to the failures, of the Part-I and Part-II Examinations of the First Degree in the Faculties of Arts, Science, B.G.L./LL.B. Part-I, LL.B. Part-II, in the Faculty of Law, First B.P.E., Second B.P.E., M.M.Ed.Part-I (i.e. B.M. Ed.) in the Examination in the faculty of Ayurveda First, Second and Third Year B.E. & B.Tech. First, Second B.Sc. (Tech) Examinations in the Faculty of Engg. & Tech. on getting Exemption. For calculating $\frac{1}{2}$ the number of subjects prescribed for the examination. **(As per the**

scheduled appended to this ordinance) For calculating $\frac{1}{2}$ the number of subjects, fraction, if any, shall be ignored.

AND

Whereas, the provision made under clause 2 of para 15 of Direction No.19 of 2015 is inconsistent with the provision made under 5th proviso of sub para (1) of para 2 of Ordinance No.10 in respect of providing for exemption and compartments’;

AND

Whereas, the inconsistency appear in Direction No. 19 of 2015 regarding the matter of ATKT is to be removed for the benefit of the students admitted for the Degree of Bachelor of Physical Education in the Faculty of Education;

AND

Whereas, the matter is required to be regulated by an Ordinance and Direction No.19 of 2015 is not converted in to an Ordinance.

AND

Whereas, the matter provided under clause clause 2 of para 15 of Direction No.19 of 2015 is required to be withdrawn from the said Direction.

AND

Whereas, the matter is to be regulated immediately for the benefit of the students for their admission on the basis of ATKT rules applicable to the Degree of Bachelor of Physical Education in the Faculty of Education.

Now, therefore, I, Dr.Siddarthavinayak P. Kane, Vice-Chancellor, Rashtrasant Tukadoji Maharaj Nagpur University, in exercise of the powers conferred upon me

under sub section (8) of section 12 of the Maharashtra Public Universities Act 2016 i.e. Maharashtra Act No.vii of 2017, do hereby issue following directions:

1. This Directions shall be called “Examinations leading to the degree of Bachelor of physical Education, first to last semester in Credit Based semester pattern in the faculty of Education (amendment Direction, 2017).”
2. This direction shall come into force with effect from the date of its issuance;
3. Provision made under clause 2 of Para 15 of Direction No.19/2015 relating to Bachelor of Physical Education, first to last semester in Credit Based Semester pattern for the award of Degree of Bachelor Physical of Education (2 year Degree Course), full time in the faculty of Education, hereby withdrawn.
4. Provision made under proviso 5th of sub para into (1) of para 2 of original Ordinance No.10 in respect of providing for exemption and compartment shall be applicable to the students of the Bachelor of Physical Education Degree Course from the session 2016-2017.
5. Provision made under 5th proviso of sub para (1) of para 2 of original Ordinance No.10 in respect of providing for exemption and compartment is based on the annual pattern system of the examination for the purposes of allowing to keep term in the next higher class. This annual pattern system of examination be treated as semester pattern system of examination for the purposes of A.T.K.T for B.P.Ed (Two Years) examinations
